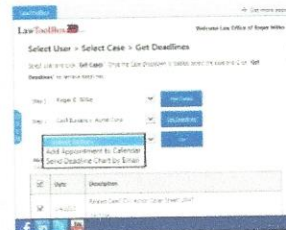

8. **LawToolBox: Integrating deadlines with Microsoft.** Last year, I reviewed LawToolBox, a cloud-based deadline calculator for state and federal courts. As I noted then, a nice feature of LawToolBox is that it can be integrated with Microsoft Outlook, so that deadlines and notifications appear there. At Techshow, LawToolBox announced two new apps that integrate its deadlines within Office 365 for Legal and Windows 8.1. The **Office 365 app** works with Outlook 2013 and Outlook 365, allowing users to retrieve and email deadline charts for any of their cases; generate and email date-range reports of upcoming deadlines by attorney, practice area or group calendar; and import deadlines into their Outlook calendar. The Windows app lets users access their case deadline charts from any Windows 8.1 device.

>> LawToolBox added another legal app, **Deadlines a La Carte**, to Office 365, providing it to customers via **Office.com**. The itemized deadline app lets attorneys buy deadline calculations one at a time. From the Outlook 2013 App Bar, an attorney selects the jurisdiction, the court rule and trigger date, e.g., trial date, to generate a list of deadlines that can be shared with cocounsel or others via email. Prior to the La Carte app, LawToolBox developed the **Court Deadline App** for Outlook and the **Court Deadline App** for Windows.

Q: In my work as a paralegal, I use Outlook every day to calculate dates for legal hearings. For example, the calculator determines what date falls 45 days after Sept. 9. Outlook then takes me to the calculated date. But the iCalendar program for the iPhone and iPad doesn't have a similar feature. Is there a way to make these calculations through a downloadable app?

A: Outlook-compatible apps for iPhones and iPads provide only simple calendar functions, such as creating new events for a specific date and time.

But legal service firms, such as LawToolBox.com (see tinyurl.com/ln4vm5w for a video tutorial), offer online date calculators that automatically update your Outlook software via e-mail.
